

RSAD Grant Scoring Rubric

Scoring criteria. Applications that are received by the deadline established by IEDA and determined to be eligible by IEDA staff will be given a numerical score between 0 and 100. The higher an application’s numerical score, the more likely it will receive funding under the program. The criteria used to score the applications and the maximum number of points that may be attributed to each criterion are as follows:
